RANGE SAFETY RULES

<ol style="list-style-type: none"> 1. All commands and directives given by the Range Master will be obeyed immediately 2. Treat all firearms, at all time, as if they are loaded. 3. Except when on the firing line, in a box, case, or holster, all firearms will be unloaded and the action will be open. 4. Except when on the firing line, a holstered firearm will be unloaded with the hammer down and the magazine out, if appropriate. 5. Firearms will be loaded and unloaded only on the firing line. 6. When on the firing line, firearms will be pointed down range except when holstered. 7. Dry firing, practice loading, and practice drawings will be done only on the firing line. 8. When giving to, or accepting from another person any firearm, it will be unloaded with the action open. 9. No one will enter the range with a loaded firearm except law enforcement. 10. Anyone who observes an unsafe act will call a cease fire. 	<ol style="list-style-type: none"> 11. When the command "Cease Fire" is given, all shooters will immediately stop firing, unload, open all actions, lay firearms on the benches, muzzles pointing down range and step back from the firing line. 12. A shooter who experiences a malfunction, jam, or stoppage with his firearm, will not remove that weapon from the firing line; he will lay is on the bench, with the muzzle pointing down range and bring the Range Master to the gun for assistance. 13. No one will go forward of the firing line, for any reason, without the permission of the Range Master. 14. No more than one shooter at a firing position without the permission of the Range Master. 15. Any shooter or prospective shooter suspected of recently using drugs or alcohol will not be allowed to shoot. 16. Conduct by any shooter deemed inappropriate, unsafe, reckless, or negligent by the Range Master will be considered grounds for removal from the range. 	<ol style="list-style-type: none"> 17. Eye and ear protection will be worn on the range at all times. 18. Discharge of firearms may produce lead dust. Excessive inhalation or ingestion of lead dust may be adverse to health. No smoking, eating, or drinking is permitted on the range. 19. Good hygiene should be practiced. Wash your hands and face after firing. 20. Pregnant women are advised to confer with their physician prior to use of the range, especially where they participate frequently in shooting activities. 21. Children under 18 are not permitted, unless accompanied by a parent at all times while on the range. Children under 10 are not permitted on the range. Children under 18 must be supervised at all times. 22. A shooter may police and keep their brass. All other brass belongs to the range. 23. <u>STEEL CORE AND STEEL JACKED AMMO IS NOT ALLOWED ON THE RANGE.</u> 24. Membership sales are final with no refunds. Nor will memberships be prorated or partial refunds issued. Memberships cannot be transferred to other individuals.
